3. CITT Code of Professional Ethics

As professionals in logistics management, CITT-Certified Logistics Professionals (**CCLP**s) are obliged to comply with the Code of Ethics prescribed and adopted by CITT to uphold the integrity of the profession and CITT as a whole. Professional standing requires that members uphold and abide by the By-laws, the Code of Ethics and such Board Policies of the CITT as may be in effect from time to time.

Each certified CITT member shall agree to the following standards of conduct:

Personal Conduct: In personal practice, to do such things as are necessary to uphold such principles as are conducive to sound logistics policies and practices, designed to serve the public interest and the betterment of society generally, and to have the public interest as the paramount goal.

Transparency: To place the interests of the member's company, employer, client or supplier before their own interest, and to have the duty of revealing the facts in any situation where their private interests conflict with those of the company, employer, client or supplier.

Integrity: In their professional practice, not to engage in any activities deemed to be dishonest, fraudulent, misrepresentative or otherwise illegal, but to conduct themselves in duties assigned and/or in relations with other members in the public interest with integrity, discharging the same with that sense of trust and responsibility as befits the status of the profession.

Brand Integrity: To conform to the appropriate use as determined by CITT's Board of Directors in regards to the use of the CITT Brand, insignia and such designations or award(s) of excellence as CITT may confer on the member.

4. Next Steps to Reinstatement and Benefits of Becoming a CCLP

Once your application is approved, you will receive an invoice for your annual professional fee (member dues). **Payment of this fee is the final step to reinstating as a CCLP and fully certified member of CITT.**The current annual fee is \$425 + applicable taxes.

Once your professional fee has been received and processed, you will be notifified that you are officially a **CCLP** designation holder and certified member of CITT in good standing, and will once again be able to:

- Display the credential CCLP after your name and refer to yourself as a CITT-Certified Logistics Professional
 as part of your credentials on your business cards and professional correspondence, your resume, your
 LinkedIn or other profiles, your email signature and other similar places.
- Have your name and achievements/active volunteer contributions listed on the official, publicly-accessible
 & widely-promoted <u>List of Current CCLPs</u> and create a professional profile in CITT's <u>SCL Talent Pool</u>
- Receive a new CCLP designation certificate (if you were originally certified before November 2013) as well as a the seal indicating your designation is current for the calendar year.
- Apply for openings on the CITT Board of Directors and the executive of CITT Local Area Councils.
- Access the value-adding support and services of CITT membership such as regular, <u>FREE webinars</u>
 (and the full library of <u>archived webinars</u>), view and post <u>job postings</u> on the exclusive CITT career centre, browse the searchable, online members-only <u>CITT directory</u> and more.

5. Members-Only CITT Directory

Accessible only to **CCLP**s and **CCLP** candidates, CITT hosts a <u>searchable directory</u> with business contact information for members of the CITT community. **CCLP**s make their information available in this directory as part of being a supportive, collaborative community of supply chain logistics professionals. - Pay the annual professional fee (member dues/annual renewal fee) as set by the Board of Directors.
 Note: After the first year, you will receive an annual renewal notice in October for your annual fee, which is due on December 1 each year.
